APPROVAL OF MINUTES:

TREASURER'S REPORT:

Alan advised that as of November the association is about \$7000 over budget. The motion carried unanimously**. With Stu moving into the presidency, it opened the Vice President position, so **Stu made a motion to appoint Bill as the Vice President, Bob Westfall seconded. The motion carried unanimously**.

OPEN FORUM:

Owners asked about the delinquent accounts, the roof contract and information regarding the engineer, which that Board has not selected as of yet.
